1. Membership Categories: Please check your household membership category.

4. Building Fund Pledge: According to CBI policy, each membership unit is expected to make a one-time contribution of \$1800 to the Building Fund. This money is used to cover repairs and maintenance, and as a base for future property purchases. Members usually pay \$360 per year over five years. As with respect to dues, we ask each family to pay only the amount they determine they can afford to pay. *Note: out of town and student members are exempted from the Building Fund Pledge.* (Check one.)
